

**RESOLUTION OF THE BOARD OF DIRECTORS OF THE
SUN VALLEY WATER AND SEWER DISTRICT
RESOLUTION NO. 2015-01**

WHEREAS, the Sun Valley Water and Sewer District currently has an established user fee schedule applicable to each distinct category of services provided from its municipal water system, to-wit:

- (a) For users located within the District the current service rate is \$1.05 per 1,000 gallons of water provided to metered water users for irrigation and similar metered uses ("Metered In-District Rate"); and \$43.00 per quarter, per equivalent connection, for non-metered water usage ("Non-Metered In-District Rate").
- (b) For users located outside the boundaries of the District the current service rate is \$1.58 per 1,000 gallons of water provided to metered water users for irrigation and similar metered uses ("Metered Out-of-District Rate"); and \$64.50 per quarter, per equivalent connection, for non-metered water usage ("Non-Metered Out-of-District Rate").

WHEREAS, the Sun Valley Water and Sewer District also currently has an established sewer user fee for customers located within the District of \$50.66 per quarter for each equivalent connection to the District's central sewer system ("Sewer User Fee"); and

WHEREAS, the Board of Directors, pursuant to the provisions of Idaho Code § 42-3212, has reviewed its established user fee structure, and has determined that an increase therein is at this time reasonable and necessary;

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors that effective December 1, 2015, and continuing thereafter until duly amended, the following user fee rates shall be applied for services provided by the District:

- (a) The Metered In-District Rate shall be increased to \$1.10 per 1,000 gallons of water.
- (b) The Non-Metered In-District Rate for water shall be increased to \$45.11 per quarter, per equivalent connection.
- (c) The Metered Out-of-District Rate shall be increased to \$1.66 per 1,000 gallons of water.
- (d) The Non-Metered Out-of-District Rate for water shall be increased to \$67.66 per quarter, per equivalent connection.
- (e) The Sewer User Fee shall be increased to \$53.14 per quarter, per equivalent connection.

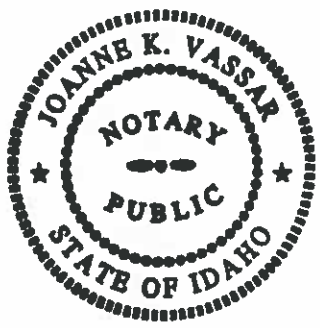

RESOLUTION NO. 2014-02**

WHEREAS, the Sun Valley Water and Sewer District currently has an established user fee schedule applicable to each distinct category of services provided from its municipal water system, to-wit:

- (a) For users located within the District the current service rate is \$1.02 per 1,000 gallons of water provided to metered water users for irrigation and similar metered uses ("Metered In-District Rate"); and \$41.75 per quarter, per equivalent connection, for non-metered water usage ("Non-Metered In-District Rate").
- (b) For users located outside the boundaries of the District the current service rate is \$1.53 per 1,000 gallons of water provided to metered water users for irrigation and similar metered uses ("Metered Out-of-District Rate"); and \$62.62 per quarter, per equivalent connection, for non-metered water usage ("Non-Metered Out-of-District Rate").

WHEREAS, the Sun Valley Water and Sewer District also currently has an established sewer user fee for customers located within the District of \$49.19 per quarter for each equivalent connection to the District's central sewer system ("Sewer User Fee"); and

WHEREAS, the Board of Directors, pursuant to the provisions of Idaho Code § 42-3212, has reviewed its established user fee structure, and has determined that an increase therein is at this time reasonable and necessary;

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors that effective December 1, 2014, and continuing thereafter until duly amended, the following user fee rates shall be applied for services provided by the District:

- (a) The Metered In-District Rate shall be increased to \$1.05 per 1,000 gallons of water.
- (b) The Non-Metered In-District Rate for water shall be increased to \$43.00 per quarter, per equivalent connection.
- (c) The Metered Out-of-District Rate shall be increased to \$1.58 per 1,000 gallons of water.
- (d) The Non-Metered Out-of-District Rate for water shall be increased to \$64.50 per quarter, per equivalent connection.
- (e) The Sewer User Fee shall be increased to \$50.66 per quarter, per equivalent connection.


